T3 Silver Birch. This sapling is cramped in between a well established beech and a conifer and is distorting the shape of both of these. It is 4 or 5 years old and I would like to fell it completely.

I do not propose to replace these trees directly as there are many other Silver Birch saplings not shown on the sketch plan along with Hawthorn, Alder etc. which are not badly positioned close to walls or buildings.

I would ask one of the local tree surgeons to carry out the work.
