January 2025 downed a small tree in our garden (Priory Gardens) and we are dealing with this. Right in the middle of the garden, about 10m leeward of the downed tree, is a huge mature willow tree. It is the signature tree of the garden, very spectacular and we don't want to lose it if we don't have to. However, it has tilted in the storm and is leaning over and towards the detached garage. If it goes down it is likely to take half the garage with it. The lowest branches on the leeward side, branches that I could walk under whilst mowing the lawn last summer, are now beneath my chin. Builders working on the adjacent house say they were very worried at the height of the storm and thought they could see the roots moving. I asked Max Reynolds to advise and I believe he spoke with Graham Nicholson, tree officer for Cumbria. I fear that the only safe option is to take the tree down and Max is willing to do the work if permission is granted. If it is taken down then we would immediately plant a replacement Salix Babylonica. Beethams tell me they can source a good replacement for us. Please advise ... leave it and keep our fingers crossed, or play safe and take it down, replacing with a new tree?
